In this issue you will see that we continue to be busy and look forward to seeing many of you at our AGM in May. Please come and I promise to keep the formal part of this event short. This year we have the new Chief Executive Officer of Mole Valley District Council, Karen Brimacombe, as our guest speaker. Along with our Councillors Karen will be able to respond to the questions about what both MVDC and SCC are doing now and in the future.

Council Tax has gone up and SCC financial issues are well publicised, as are police budgets. We have challenged both organisations as it appears that we are all paying more for less services. The closure of the police front desk at Dorking, the lack of neighbourhood policing and the continual deterioration of road and drainage are questions you, like us, may want to seek answers to.


After many years of lobbying and technical inputs to SCC there is some good news as we are told at last solutions for the long-standing Dorking Road flooding and silting of gullies will be addressed in November of this year. On the negative side even though we fight hard for a solution the flooding at the bottom of East Street looks like being with us for many years yet.

Elsewhere here you will see an article about the Bookham Youth Centre on Lower Road. Way back in 2007, with notice of closure, a combined village group got together and persuaded SCC to let the village run the centre. This has been successful, but SCC again are now threatening to close the building in 2019, without replacement. Along with others we are pressing SCC for solutions. Updates will be at the AGM and on our web site including, if necessary, how to respond to this news.

We now know the decision on the future of the Howard of Effingham school in that the Appeal was allowed. For Bookham this is important. 700 Bookham children attend this school, by far the biggest cohort of any local community. There may be a *(Continued on page 2)*

Judicial Review by either Effingham Parish Council or Guildford Borough Council which will result in further delays.

MVDC are preparing a new Local Plan and we are much involved. The Plan will probably propose up to 450 new dwellings per annum in Mole Valley the majority being here in the north. As MVDC at present only build around 180 dwellings per annum the scale of this challenge is evident. As I write this we here in Bookham have probably 100 new dwellings in planning or building, increasing pressures on an already stretched infrastructure.

On a better note, we planted further trees and carried out wide pruning; provided better Christmas lights and winter hanging baskets; have plans to complete the war memorial cleaning; assisted in the petition for better recognition of both villages; are working on plans for improved plantings around the High Street and Church Road; and helped secure funds for the refurbishment of the cricket square in the autumn. There was even more participation by everyone in the litter picks and there were many other tasks some small but still worthwhile.

An example was the old Lloyds building where an alarm sounded for over ten days continuously. After many attempts we found a solution particularly helped by Rohallion Security in Church Road who kindly provided a technician to resolve what was someone else's problem at no expense. Thanks to them for this welcome support.

We have done more and please come to the AGM where we can discuss what else we could do.

I look forward very much to seeing you all in the Barn Hall in the evening of May 17th.

BUSES & TRAINS

Since our Autumn 2017 Newsletter Buses Excetera had to withdrew the recently introduced 489 Leatherhead to Merstham bus service due to lack of passengers.

The 479 Epsom to Guildford service continues to serve our village, but, from the 19th February 2018 the 16:10 bus from Epsom now runs 10 minutes later and, unfortunately again due to lack of passengers the last bus at 19:10 from Epsom to Effingham and the return bus at 20:04 to Leatherhead were withdrawn.

Trip to Ranmore Common

This trip mentioned in the Autumn 2017 Newsletter is still possible to do, but without using the 489 bus service.

Our train services continue to serve us and we await news of Crossrail 2 which will come to Epsom and how it could extend our connections.

A Pub Crawl!

This can be taken from either Great Bookham and Little Bookham via Effingham to East Horsley, or in the reverse direction. Don't forget to check the bus timetables and use the 479 for the return or outward journeys. But, the latest version of the free Surrey County Council timetable which is now available from the libraries was published before the above-mentioned timetable changes.

From the centre of Great Bookham the first pub is Ye Olde Windsor Castle, Little Bookham Street, followed by the Sir Douglas Haig and The Plough in Effingham village and at the end of the journey is the Duke of Wellington, East Horsley. Maybe try doing it in sections using the several footpaths that link the villages well away from the A246.

There is no charge to place a poster on BRA Noticeboards, but there is a set of criteria which the Association use, in priority order, to determine what we put on the boards. They are:

- 1. Events that the BRA organise.
- Information provided by the Council (Surrey or Mole Valley) or the Police.
 e.g. elections, libraries, public meetings etc.
- 3. Local events in Bookham, or nearby, organised by local charities.
- 4. Any other local events.
- All posters should be:
- A4 or smaller.
- Be of interest to Bookham Residents.
- Be respectful to others.
- Be non-political.

For any event, I will not leave the poster up for longer than say two months or until the event date has passed.

Obviously if I am short of space on a particular board then I will remove posters in reverse priority order.

I have three main boards:

- At the southern end of the High Street next to the Co-op.
- Next to the car park entrance in Lower Road.
- In the Lower Shott car park next to the ticket machine.
- I also have limited access to other Community noticeboards making five in total.

If the poster is going to be on the noticeboard for longer than two months you might want to laminate it. This is to protect any colour, as the boards do get damp overnight.

PETITION FOR GREAT & LITTLE BOOKHAM POSTCODE

Hopefully you will have seen signs on the BRA notice boards, received a flyer, or seen details on social media about the petition to get "Great" and "Little" readded to our addresses. You may not realise, but when postcodes were created back in the 1970's, when they created KT23 for the Bookhams, they removed the pre-fixes of "Great" and

"Little" and they have gradually been getting more and more forgotten and disused ever since. This means that when your address is created using the postcode our village name is just Bookham.

I contacted Royal Mail about the issue, and they are happy to add Great and Little back onto Bookham addresses, and will conduct a written consultation to all affected addresses. In order for this consultation to start, Royal Mail need the approval of MVDC and our MP Paul Beresford.

MVDC have asked me to create this petition, in order to see what level of support there is in the Bookhams for Great and Little to be re-instated, before giving permission for Royal Mail to conduct their own consultation to residents.

You may wonder why this is important, but if we do not seize this opportunity to correct our village names now, it is unlikely that Royal Mail will consider taking the time to do this again in the future. Great and Little Bookham have partially merged over the years due to house building, but there is still a lot of the border between the two villages that is still open countryside. The only part that has merged with housing is along part of the east side of Little Bookham Street. To the north of Sole Farm Road there is Little Bookham Common, and to the south we have the fields in Rectory Lane, and the farm land of Polesden Lacey dividing Great and Little Bookham.

It would be a great shame for our two

villages to lose their historic identities. They both still have their own churches, village halls, commons, and schools. Our villages are no less deserving than East and West Horsley, Stoke D'Abernon or the Clandons, which are all small villages recognised correctly by Royal Mail, so please support our campaign to keep our correct village names, before they are lost forever. Future generations will wonder why we ever allowed them to be lost.

DO YOU KNOW THE DIFFERENCE?

For many years, there has been confusion about these two very important and active organisations, but the difference is very clearly defined.

The Bookham Community Association play a vital role in running the Old Barn Hall in Church Road and most of the funding for this historic part of the village is derived from the BCA's organisation and income from Village Week. The BCA also publishes and distributes the Bookhams Bulletin four times a year. Most organisations in the village are affiliated and appear regularly in the magazine.

The Bookhams Residents' Association, on the other hand, have an extremely wide range of responsibilities, such as working closely with the six local councillors in order to see that improvements are carried out, which often involves liaising with Mole Valley District Council.

Environmental matters, such as flooding and infrastructure, particularly roads, are carefully monitored by the BRA; in addition, a close eye is kept on planning applications via a small sub-committee and there are individual committee members dealing with education; health; transport; trees; Christmas lights and hanging baskets, the last two with invaluable help from a closely linked group of traders - the Bookham Retail and Business Association (BRaBA).

It also takes time to co-ordinate the increasingly popular BRA monthly litterpick and another task that may go unnoticed is maintaining the village noticeboards; not forgetting the hours spent preparing and distributing The BRA Newsletter, which is published in the spring and autumn. A huge 'thank-you' is due here to over 130 Road Stewards who deliver copies to all our members.

Although the BRA and the BCA are separate in terms of administration and the roles that they carry out, there is a very close working relationship between them. One way of summing up the difference in the two associations is that the BCA have the pleasure of social events during Village Day and Village Week, as well as varying functions at the Barn Hall, whereas the BRA have to deal mostly with problems that occur in the village on a regular basis. However, a lot of satisfaction can be gained when such problems are dealt with successfully.

PROTECTING YOUR DATA John Howarth

Company Secretary

Some of you will be aware that new Data Protection Regulations come into effect in the UK on May 25th this year. They are called the General Data Protection Regulations (GDPR). They are designed to replace the existing Data Protection Act and to give greater protection and rights to individuals in respect of organisations who hold personal information about them.

The Bookhams Residents' Association falls under these regulations since it keeps information about its membership.

It is the intention of the BRA to comply with the requirements of the GDPR. It is a legal requirement to do so and the ICO (Information Commissioner's Office) has powers to levy fines on organisations that do not do so.

The initial responsibilities of the BRA are:

- to inform its membership about the Regulations,
- to indicate to the membership its intention to comply, and
- to give a brief outline to its members as to what their rights are under the Regulations.

Hence this section in the Newsletter.

- As members of the BRA you will have the following rights under the Regulations:
- The right to be informed about the data held about you
- The right to have confirmation that the BRA is holding your data and that the BRA is processing your data lawfully
- The right to have the data corrected if it is inaccurate or incomplete
- The right to have your data erased from the BRA files
- The right to restrict how the BRA processes your data
- The right to object to how the BRA processes your data.

There are six bases for lawful processing:

Consent of the individual (the "data subject")

e.g. the organisation has asked for and has received permission (with evidence) to hold information about the "data subject"

Performance of a contract

e.g. someone has signed up to membership, paid a membership fee, and has expectations that a service will be delivered

Legal Obligation

e.g. the organisation has a legal requirement to keep the data

Vital Interest

e.g. disclosure of personal information in an A&E Department when it could save someone's life

Public Task

(This applies mostly to public authorities)

Legitimate Interest

e.g. informing the membership about new activities that the organisation is carrying out.

No single basis is more important than any other when it comes to defining lawful processing, and only ONE basis is needed to define lawful processing.

For the BRA the two most relevant ones are No. 3 – Legal Obligation and No 2. – Performance of a Contract.

Because the BRA is a Company Limited by Guarantee the Companies Act defines the information it keeps about its membership – hence the Legal Obligation; and because the members pay a subscription there is a Contract.

There is an implied assumption that by joining and paying the subscription individuals are giving their consent.

BOOKHAM'S GREEN SPACES Frances Fancourt

Mole Valley Parks team have planted two beautiful new Cedar trees on White Way. This follows the loss of the magnificent Cedar of Lebanon trees which were originally planted in Bookham Grove House in the 1700s. The last was felled

to a large multi-armed stump in 2016; two were also lost in White Way in the Great Storm of 1987. The oldest in Britain is a mere 250 years old – in Turkey and Lebanon these trees live for up to 700 years. In 50 years' time our new trees will be sprightly young teenagers, showing off their beauty for our grandchildren. How sad it would be if we denied them that possibility.

Clearance work has also taken place around Bookham improving sight lines and removing dead or dangerous branches. We have commissioned this using an allowance from Surrey County Council who own our verges. The pathway along Dorking Road have been cut back, and the sight lines on the approach to Howard of Effingham School has been improved by the removal of undergrowth.

Although this is technically in Effingham, it is our scholars and their drivers using the Lower Road who will benefit.

After removal of dead trees and stumps we have also completed a small amount of replanting in Pine Dean, Tudor Close, Howard Road, Crabtree Lane and The

Garstons, which in 5 to 10 years should repay us by showing off its succession of blossom and autumn leaf colour for all the residents of Bookham.

Norbury Park is set in beautiful open countryside and lies within the Surrey Hills Area of Outstanding Natural Beauty.

An ancient site, Norbury may have been one of the Mickleham manors mentioned in the Domesday Book of 1086. The Locke family built the present Norbury Park house in 1774 and since that time the house has been altered and changed hands on numerous occasions. Although the house and its grounds are still in private ownership, Norbury Park itself is managed by Surrey Wildlife Trust.

Today the Park is managed to provide wildlife-rich habitats and a range of opportunities for public access and recreation.

The reserve is made up of a mixture of woodland, grassland and various areas of farmland. Due to the range of habitats it is an important haven for many plants and animals and a large part has been designated a Site of Special Scientific Interest and a Special Area of Conservation.

Norbury Park Volunteer Group was set up in 2015, and local residents have been fundamental in helping care for the reserve. In the last year alone, the group have achieved so much, including clearing vegetation around a hedge that was planted as a legacy, removing old plastic tree tubes and re-instating electric fencing for cattle grazing on the grassland in Walnut Tree Clump. They also did some sterling work upgrading the existing coppice protection fence in Blackberry Wood.

For a short time during this winter, the volunteers helped coppice an area of hazel in Updown Wood. In the past, areas of Norbury have been coppiced regularly - cut down to just above ground level and allowed to regrow - to provide bean and pea sticks and be used for hedge-laying materials. This is a traditional practice in woodland management that we use today to encourage diversity in wildlife. In springtime the woodland floor is covered with bluebells, which attracts numerous feeding insects.

The group also very recently cleared overgrown vegetation along the bridleway, near to the old London Road Bridge and repaired a broken bar way.

There has never been a more exciting time to get involved, whether you can spare a few hours or a full day. Volunteering provides a chance to get involved in local wildlife projects and the opportunity to meet new people while making a positive contribution to looking after the local area.

Norbury Park Volunteer Group meets every third Friday of the month, carrying out various activities to preserve this invaluable area of Surrey countryside.

BOOKHAM YOUTH & COMMUNITY CENTRE: IS THE END NIGH?

Bookham Youth & Community Centre, situated opposite the Anchor pub on Lower Road, has been a valued and important part of the village for many years. But as reported over the years it has a finite life due to its ageing condition and the lease from Surrey County Council (SCC) expires in February 2019. It is run by trustees and other volunteers and incorporated into a charity, Bookham Youth & Community Association Ltd known to all as BYCA.

In 2010, with the support of Bookhams' County Councillor, BYCA started discussions with SCC. This included a meeting with the Leader of the Council, Cllr. David Hodge, on 30 March 2011. The agreed plan was that a new Community Centre would be built whilst the existing Centre remained in use. A site for this was identified. Then the land of the existing site, approx. 1 acre, would be sold to retrospectively fund the new facility.

The lease expiring next year was considered by SCC as more than adequate time to achieve this objective. Despite their optimistic message in early 2017 of a positive outcome that was relayed by County Councillor Clare Curran, BYCA raised concern at the lack of direct communication on progress given that there was less than 2 years to the expiry of the lease.

Despite chasing, no response was received and so BYCA wrote at the beginning of October 2017, requesting a new lease so that security of tenure was assured pending a new build decision.

After again chasing for a response, contact was made in December and in March BYCA was advised by an Officer of SCC that the lease would not be renewed. Also, concerning the provision of a replacement facility, her opinion was that it was unlikely "a solution will be found which will be viable and cost effective". Cllr Curran had not heard of this until she was advised by BYCA. Needless to say this was disappointing and unexpected news.

However, Cllr Curran, BYCA and BRA have escalated the matter to the responsible Cabinet Member of SCC to whom it was also news. The result has been a new impetus to find a long term solution in the form of a replacement facility. The priorities are:-

- 1. An extension of the occupation of the existing Centre for as long as possible.
- 2. Provision of a new community facility to replace the much needed lost capacity of the existing Centre.

BYCA Chair & Cllr Curran met with & briefed the Cabinet Member at the Centre on 27 March and an extension of 6 months to August 2019 was confirmed with a further period remaining a possibility. The community value of the Centre was understood and he said SCC will now do all it can to provide a solution as a priority and minimise any transition period between existing & potential new facilities.

BYCA are very disappointed that SCC have taken eight years to get to this position, especially as it was exactly to prevent this situation that the work was initiated so long ago!

GREAT NEWS! PLANNING APPLICATION FOR EXTENSION APPROVED!

Construction of a first floor extension to provide a new social meeting SPACE for classes, meetings and social events at South Bookham SPACE has received the green light from MVDC planning.

NOW – we will need to work very hard to raise the essential funds to pay the balance by huge local support in general but particularly for:



DRAINAGE

The BRA continues to try and resolve the villages' many historical drainage problems through the Bookham Flood Forum (BFF), along with SCC Highways (SCC), Thames Water (TW) and the Bookham Flood Action Group (BFAG). The last BFF meeting was held on 19th February 2018 and was followed up by a site visit on the 9th March.

Over the last few months very bad problems have been experienced with the foul drainage in Little Bookham Street (LBS) between Sole Farm Road and Burnhams Road. This has resulted in a surcharging foul manhole in LBS itself, foul drainage flooding gardens in Oakdene Road and even foul backing up inside properties in the area.

Following reports from affected residents and the BRA, TW came out and cleared the foul drain from Bookham Common back to Sole Farm Road. The line was jetted to remove heavy silt, rag, fat, oil, grease and other debris. This was followed by root cutting and a full CCTV survey. The sewer was left clear and free-flowing.

Further south on LBS, between Bennetts Farm Place and Lower Road, TW have been reminded that previously blocked and collapsed lengths of drain have yet to be jetted or replaced.

As a result of reduced County Council funds and resources, SCC Highways have yet to carry out further investigations on Lower Road between East Street and the Squareabout, which have been discussed in great detail in recent issues of the Newsletter.

The importance of completing the investigations and carrying out remedial works was stressed during the 9th March site visit and SCC will investigate other possible sources of funding e.g. from the Environmental Agency and other agencies.

Proposals for drainage improvements at the Dorking Road junction with the Polesden Lacey access road have unfortunately been postponed until later this year at the request of The National Trust, so as not to affect entry to Polesden Lacey.

There are many other areas where the BRA continue to press SCC and TW for action, including:

flows from Preston Farm result in flooding.

- the central area of Bookham from the High Street/East Street to The Park/ Mill Close, where a study is proposed, subject to finding funding.
- the footpath from Greenacres to The Park where the outfall is blocked and has no adequate outfall.
- Kennel Lane/The Glade where there are root blockages in the main outfall to Fetcham.

ROADS Michael Agius

At the 14th March 2018 Local Committee, Colin Kemp, Surrey County Council's Cabinet Member for Highways, gave an update on SCC's programme of major road repairs called Project Horizon.

Unfortunately, as a result of funding cuts, the programme is slipping and the resurfacing of Eastwick Drive and Crabtree Lane are now only included 'for future consideration in future years'. The resurfacing of other roads that used to be in the programme i.e. Little Bookham Street, Meadow Way/The Copse [Eastwick Drive to The Copse], Willow Vale [The Copse to the end] are no longer mentioned. The BRA will press for these roads to be reinstated in the programme but in view of the funding cuts, implementation is likely to be in the distant future.

Under the programme of capital Integrated Transport Schemes (ITS), Developer Funding is included this year to provide kerb build outs and crossing ramps at the entrance to the Eastwick Schools on Eastwick Drive, in order to control parking and make safer crossing points.

The BRA will continue to press SCC for

the need to improve Rectory Lane, to provide a footway on the east side of the road from The Grange south to the A246 and widening of the carriageway to a consistent width. However implementation is dependent on land being acquired from the fields east of the road, as well as a fairly large amount of funding becoming available for construction. Funding is only likely to become available from Developer Contributions, should a major development be forthcoming in the immediate locality.

TRAFFIC SPEEDS IN EAST STREET

The behaviour of drivers using East Street and in particular their speeds, has been raised by residents living in the road. To gauge the extent of the problem, a speed survey was carried out by the Police between 3rd and 10th January 2018, when the total number of vehicles recorded was 15148, with 7,632 Northbound and 7,516 Southbound.

The average speed of all vehicles recorded over the 7 days was 23 mph the average Northbound being 22 mph and Southbound 24 mph, well below the 30mph speed limit. In addition the accident records show no personal injury accidents.

Finally signs have been erected to warn HGV drivers that the road is unsuitable for them to use. With all this in mind, it is difficult to know what can be done physically to improve matters.

However, in consideration for those who live in East Street, we would ask all Bookham residents who use the road, to drive with as much care and attention as possible.

RIPERIAN RESPONSIBILITIES

In previous editions of the Newsletter, the Riperian Responsibilities of residents in Childs Hall Road and Sole Farm Avenue who live alongside the ditch between the Lower Road Recreational Ground and Little Bookham Common have been emphasised.

Whilst some home owners maintain and have improved their lengths of the ditch, notably immediately north of Lower Road, other lengths are known to be overgrown and even filled in. This results in the flow of water in the ditch being obstructed and backing up, resulting in flooding of properties and infrastructure to the south, as happened at Lower Road in the winter of

The BRA would kindly request all those who live alongside the ditch to ensure that it is kept clear at all times.
