Bookham Youth & Community Centre: Delivery Update

Progress towards achieving a new Youth & Community Centre for Bookham has been frustratingly slow. We are getting there, but we still need your support.

ONE YEAR ago Mole Valley District Council (MVDC) granted outline planning permission, with conditions, to Surrey County Council (SCC) to build a new Youth & Community Centre to the side of the Lower Rd Rec Ground. The new centre – the biggest investment in a community facility by our local authorities in Bookham for over 50 years – is a vital commitment to the future of our youth and wider community.

What's been happening and why so long? The short answer is "process & bureaucracy".

Since outline planning approval was granted, the relevant community groups (Leatherhead Youth Project: Bookham and Bookham Colts), with the active support of the BRA, have been working with SCC on the internal design of the new building to accommodate safeguarded youth

work and flexible community space, including Sports England and Early Years compliant facilities. All within the agreed outline plan and conditions. The design work was completed earlier this year.

BYCA's role will be to manage the new Centre on a "not for profit" basis under a sub-lease from SCC as owner of the building which in turn will have a ground-lease from MVDC which owns the land. MVDC is to continue to manage the pitches, play area and skateboard park.

The next stage, once the ground-lease had been agreed, was to complete the external design, cost the construction and commission the building of the new centre. At that point SCC planned to share the design with the community for information and feedback prior to a detailed planning application being submitted to MVDC in May 2022. Unfortunately progress stalled as, we understand, there were stumbling blocks over the proposed terms of the ground-lease to SCC, and thus the sub-lease to BYCA, bringing the viability of the whole project into doubt.

The good news is that thanks to interventions, largely instigated by BRA & BYCA, the issues were resolved with the involvement of senior officers of the two local authorities in late April. BYCA has yet to see a draft sub-lease but assurances have been given that it will

be on the same general conditions as that of the old youth centre but with a longer term.

Our understanding is that the two local authorities now plan a joint communication on the new Centre. We welcome MVDC and SCC working together, although at the time of writing this update, details of the joint communication have not yet been provided.

We do not want to see further delays in delivering the new Centre.

Hopefully, all the big hurdles have now been overcome. Every day of delay is a day when our youth and the community cannot benefit from the Centre. Not to forget the community volunteer time, and energy consumed as well as potential job opportunities delayed.

We will keep you informed via the BRA website. Please continue to make MVDC and SCC representatives fully aware of your support for the new Centre, and your expectation that we must ALL work together to get the job done !

Lastly, a big thanks to Peter Seaward, Chair of BRA for bringing BRA's expertise, contacts, encouragement and advice to support our volunteer efforts over the last 10 years in trying to get this project done for our young people and wider community.

Finally, the village sign at the top of the High Street in Lower Shott has reappeared. H-Signs, the manufacturers kindly provided a new sign after a problem developed with the mounting of the original sign which had to be removed on safety grounds.

Local business DB Garden Services owned by David Belsham and his always willing team are to be thanked for the solid installation. This time we hope it will stay intact longer than the previous eight years.

We are trying to arrange some illumination for the sign in what is a darker part of Lower Shott along with other new services but currently have run into problems with MVDC in gaining access to power.

What should normally be a straight forward piece of work is yet another example of the wheels of our local authorities almost grinding to a halt. I am sure we will overcome them, but again this will take a little time.

Updates from Peter Seaward

Community Infrastructure Levy (CIL)

Whenever a new building is constructed in Mole Valley the Mole Valley District Council (MVDC) raise a levy on the developer to help pay for infrastructure improvements. The amount depends on the building size and is paid at so much per square metre.

Depending on where the construction takes place a sizeable proportion of this CIL is maintained by the Council for strategic infrastructure improvements and a smaller proportion is paid to the Parish Council or where there is no Parish Council is held by MVDC on the location's behalf.

In addition, if a Neighbourhood Development Plan (NDP) is in place as is the case in Ashted and Bookham then the smaller proportion is set at 25% and where there is no Neighbourhood Development Plan as is the case in Fetcham and Leatherhead the proportion is 15%.

The 25% set aside can be used for a wide range of infrastructure improvements and any organisation can bid to MVDC for a grant. In our case we have had many bids. Some are awaiting a decision and some have been agreed. An example is the cricket square at Chrystie Rec. The square was not in decent shape and an agreed grant was provided to re-lay it. As a result Bookham Cricket Club is now thriving, and the pitch is in heavy demand from other teams throughout Mole Valley.

Other bids we have, or are in process, are for improvements to the shopping areas in the form of planters and planting, horticultural improvement around the Village Sign and toilets at Lower Shott, and refurbishment of many of the thirty-five plus benches throughout the village.

We are also in the process of putting some larger bids together to improve

both Chrystie Rec and Lower Road Rec. There are discussions at Mole Valley to change the arrangements of CIL administration.

We are fighting to ensure that this neighbourhood portion is spent in the location it comes from and not pooled with other areas. Such a change would negate the arduous work we put into our Neighbourhood Development Plan and disadvantages us against Parishes who can spend their portion of CIL how they think fit without MVDC involvement.

New BMX Track at Lower Road Rec Ground

On the Lower Road Rec the old skateboard park is to be removed as it is showing its age and is no longer fit for skate boarding.

When discussions took place with a number of young people through Mole Valley Youth Voice, Bookham Youth Project and the schools, a BMX track was the preferred replacement. This would be like the facility on the Kingston Road Rec in Leatherhead. So far, we have had simple outline discussions with MVDC who provided outline design indicator of costs and we are now in the process of turning these ideas into an acceptable CIL bid.

MVDC does not currently have funding for this project or likely soon so we will attempt to use CIL as a method of funding.

Note: This project is at an early stage.

Bookham Allotments

We were approached by the organisers of the main allotment groups in Bookham, (Keswick Road and The Approach, Bookham Common) informing us that because of lockdown the demand far exceeds supply of allotment plots here in the village. We have discussed this with MVDC and although there is a disagreement about whether the

Council have allocated or not sufficient land for this purpose it is most unlikely that any more allotments will be provided.

We have known for some time that Polesden Lacey are keen to reinstate the vegetable garden which flourished there so many years ago when it was the private residence of Mrs Greville.

We met with the Management at Polesden Lacey who are always very receptive to any ideas we have and are also keen to be part of our village community.

Many new projects were put on hold by the National Trust during lock down as visitor numbers plummeted but in our latest discussions, they tell us that they hope to get this vegetable garden project started next year. Although different from owning an allotment it may appeal to some who would enjoy what will be a challenging but rewarding task.

CCTV

We have good CCTV coverage of the High Street and would like to increase this to cover key parts of Church Road.

Last year we discussed this with the Police and Crime Commissioner for Surrey (Lisa Townsend) as some policy changes about CCTV might have been introduced. This has not materialised but financial matters about who will in future pay for the monitoring of our and many other District and Boroughs CCTV's is now a problem.

This is being discussed between the Surrey District and Borough councils but we do not anticipate a quick outcome.

We have repeatedly stressed the value of our High Street units both at MVDC and with as many layers of Surrey Police we can interact with.

Who we are, and what we do...

The Bookhams Residents' Association (BRA) is an apolitical voluntary membership organisation open to all residents of Great and Little Bookham.

The BRA is "of the community and for the community". Its purpose is to be a voice for resident's views on local issues, and to help get things done to maintain and improve life in the Bookhams.

To deliver its purpose the BRA works hard to:

- Understand local issues and views;
- Deliver recurring and strategic work, and make Bookhams views heard; and to
- Report Back to residents on what has been done on their behalf

Understanding local issues and views.

The BRA does this by:

- Gathering local views through its monthly meetings, its website, social media and correspondence, word of mouth and common knowledge.
- Providing a consultative link between residents with councillors, public authorities and utility services.
- Working with voluntary and other organisations that are involved with the social, cultural, faith, business and entertainment life of the village.
- Co-ordinating voluntary services that are of environmental and amenity benefit to the community.

Recurring work and making Bookham's views heard

The BRA delivers this in a variety of ways, including: reviewing, consulting, lobbying, advising, co-ordinating, linking, supporting, attending, and liaising on resident's behalf. The BRA does this by operating a number of specialist groups that focus on specific community interest topics:

Our strategy for 2022 and 2023

Community

Strategic Work

Strategic work generally involves topics or work with longer timescales and complex multi-organisational working. The BRA's strategic projects, some of which we have reported on elsewhere in this newsletter, include:

Flooding

Through the Bookham Flood Forum, the BRA will work with SCC Highways and Thames Water to monitor the effectiveness where remedial work has been undertaken and to bring to the forum any other flooding issues affecting the Bookhams.

Youth & Community Centre

The BRA will continue to work with Bookham Youth and Community Association, SCC, MVDC, youth workers and local residents to see this much needed project completed.

Vehicle speed.

The BRA has helped local residents liaise with SCC Highways and the Police to establish a Speed Watch scheme in Little Bookham Street. The next step is to install speed warning units in Little Bookham Street to advise motorists of their speed and encourage slower driving. We shall work with our County Councillor and Surrey Highways to identify traffic calming measures in the village.

Eastwick Park Medical Centre.

The BRA is engaging with the Doctors, MVDC, SCC and the NHS to see what it can do to help the Doctors realise their plans. Our focus is on Eastwick Medical Practice as Fairfield Medical Practice has been upgraded in recent years.

A multi-service Health Hub for North Mole Valley.

Alongside local GP practices there is felt to be sufficient demand to create a multi service health and welfare hub for the people of North Mole Valley (similar to Dorking's Medwyn Centre). This would involve joint working between the BRA and the residents' Associations of Fetcham, Leatherhead and Ashted, together with MVDC, SCC and the NHS with the aim of creating a North Mole Valley Community Health Centre.

New strategic projects,

The redevelopment of Lower Shott, will come from MVDC's new Local Plan which is expected to increase substantially the amount of housing in Bookham. That will in turn place considerable extra strain on the local infrastructure including school places, health provision, roads, sewers, and drainage - infrastructure that is already straining to cope with current demands.

The BRA will continue to lobby MVDC, Surrey County Council and other infrastructure providers to make sure that the infrastructure is improved in order to cope with the extra demands placed on it.

Reporting Back

We report back constantly, and in various ways, throughout the year:

Articles are placed on our website and in social media. We publish a Spring and an Autumn Newsletter packed full of reports on what has been done on residents behalf. We also have five regularly updated Notice Boards around the village centre, and of course there is also direct correspondence, and word of mouth.

Eastwick Park Medical Practice

The BRA has been talking with the Doctors at the Eastwick Park Medical Practice as they explore the options that might be available to them to improve the building they currently occupy, or relocate the practice to another site in the same part of Bookham. The current building is not large enough to meet the needs of the community, and its configuration is not an efficient use of space for a modern medical practice. Eastwick Park Medical Practice is very keen to engage with the community to explore all options and are so grateful for their support. Eastwick Park Medical Practice wants to work together to develop a modern, well equipped practice giving patients the best practice possible.

Most GP practices are owned by the GPs themselves and are set up as independent businesses that are contracted to the NHS. That all works well enough, but it means that the amount of bureaucracy that has to be gone through to develop a new practice is huge - not just things like obtaining planning permission from the local Council, but reams of forms and assessments to satisfy and get support from the NHS. It will be a long and complex project for the Doctors to manage, but the BRA has offered to help where it can by facilitating contacts and providing its backing in support of the Doctors plans.

The BRA subsequently engaged with senior Officers of Mole Valley District Council to raise awareness of the Eastwick Park Doctors' aspirations, and encourage assistance. Again, it is very early days, but the Council Officers were very positive about seeing what can be done to help. A round-table meeting will now be sought between key local government and NHS players, and we look forward to that meeting building momentum in support of the Eastwick Park Doctors plans.

Infrastructure

Drainage

The BRA continues to try and resolve the villages' many historical drainage problems through the Bookham Flood Forum, along with SCC Highways and Thames Water. Meetings have continued to be held on Zoom.

The winter has been generally fairly dry, thus avoiding the intense rainfall and flooding that occurred in October. Despite that local members of the Flood Forum have been in communication with the SCC Flooding Team with regard to critical areas of the village's old drainage infrastructure, prior to discussing these further at the next meeting.

Highways

Mole Valley District Council's Integrated Transport Scheme Programme for 2021/22 - 2023/24 includes the following Bookham project :

- Eastwick Park Avenue - £25,000 for construction of pedestrian improvements outside the entrance to Eastwick Junior School, similar to those constructed outside the school on Eastwick Drive.
- The programme also includes schemes for future potential prioritisation from MVDC's Road Safety central budgets :

- Lower Rd./Little Bookham Street - formal pedestrian crossing. £100,000
- Church Road - traffic calming measures. £200,000

Vehicle Activated Signs

In the last newsletter we asked for some volunteers to help with erecting, and moving around, a Vehicle Activated Sign (VAS) (or Speed Indicator Device).

I'm pleased to report that we now have a small team of volunteers and we have installed the VAS on the A246, not far from the Lower Shott car park.

If a car is exceeding the speed limit it will light up with "Slow Down" and a reminder of the speed limit.

We have all the equipment needed but permission is needed to affix the VAS and posts need to be of a certain height. Unfortunately we can't use lampposts so we will need to get some new ones erected, which will come at a cost. However, we have two viable posts and hopefully more on the way.

Also, in Little Bookham Street, two VASs will be installed, hopefully in the coming months. These will be static devices so we can't move them around, but we are hopeful of getting a second mobile device at some point in the future.

Bookham's Hidden Eyesore

Although designated in the Local Plan for development because of the constraints and joint ownership, developers appear to be reluctant to get involved.

With our Councillors we want to mount more pressure on MVDC for them to make a considerable effort to use this land for the public good.

In a similar case near to this location unused small garages just like these were taken down and affordable housing put in their place. Why cannot this be arranged here too.

Please help us if you agree by lobbying your local MVDC Councillor by showing your support for getting a drastic change to this Bookham eyesore.

Mole Valley District Council Boundary Review

The review of the existing wards in Mole Valley by the Boundary Commission has completed its first stage. For Bookham and Fetcham, the changes recommended include a completely new ward which will cross the present boundaries of our villages.

This Ward will be called Eastwick Ward and encompass parts of Fetcham such as the Ridgeway and parts of East Bookham. In our submission to the Boundary Commission, we stressed the importance of the unique identities of Bookham and Fetcham. As the new ward structure must be evened out at around five thousand voters per ward the numbers argument outranked the location case.

We can challenge and comment at the second round of consultation which we will do. This change has come about because MVDC are determined to maintain local elections every three years so every ward must have three councillors whereas previous single councillor wards were permitted.

Should our arguments not prevail we have agreed that for both our Resident Association purposes (Fetcham and Bookham) the present boundaries between us will still apply. As many will know this is not an unusual case as we already have different Parliamentary constituencies, differing post codes and so on.

Local Plan

The next stage of the Local Plan is now underway with Government Inspectors appointed and dates set for when hearings will take place. The Inspectors issued a series of questions for MVDC to answer, and all this material is in the public domain. (These can be viewed on the BRA web site).

We, along with others locally, who objected are deciding how best to respond at the various stages the Inspector has outlined.

The BRA will be sending written comment shortly and asking that we speak at one or two sessions. These will be in public at the MVDC offices in Dorking later this year. As soon as these have been decided we will publish them on our web site along with other material that may be helpful.

Surrey County Council has also come up trumps with a refreshed impetus towards street tree planting with the lovely cherry avenue outside the Lower Road Recreation Ground, four Sorbus trees in Oveton Way, and new trees on the Garstons triangle. And with this new impetus we hope to extend the tree planting throughout the village over the coming few years.

New Free Recycling Guide released by the BRA and Plastic Free Bookham

As part of the *Reduce, Reuse and Recycle around Bookham* initiative by Plastic Free Bookham, the Bookhams Residents' Association and Plastic Free Bookham have combined resources to develop an automated guide to local re-cycling services.

This free online service enables residents to simply enter the product they want to recycle and the guide automatically shows you if and where the product can be recycled. The

guide not only includes Mole Valley District Council street collections and Community Recycling Centre but also other recycling organisations for a complete picture.

Some recycling can produce funding for the benefit of a charity or community groups and this is also shown in the guide.

A major recent development is that many branches of supermarkets like the Co-op (including Bookham!), Sainsburys and Tesco now offer soft plastic recycling and this is a welcome

option to avoid some of the sorting needed for the Terracycle collections – a few Bookham Terracycle collections are still listed.

Diane Poole of Plastic Free Bookham researched and provided the content and Les Huett from the BRA built the service.

The service works on desktop and mobile devices.

To use the guide start typing in the 'Search' box. The service immediately shows you all the entries with the search phrase in them.

Click in the right-hand column to see more details of what your options are.

Want to get involved?

We are always looking for new members, and for people who want to help "do something positive" to help their local village. We currently have four specific roles that we need volunteers for:

Noticeboard Administrator

We have five noticeboards to be updated with new village notices and typically this will be weekly. The boards are all around the village so an element of walking is required between the sites. It would suit two people working together.

Minutes Secretary

Committee meetings are held eight times a year and we have four directors meetings. They are held on the first Monday in the month and the second

Monday following bank holidays. Meetings start at 7.30 pm and are face to face (occasionally they may be Zoom calls). The Minutes Secretary will produce the minutes and actions at the meetings. A PC /laptop will be required to produce and email minutes.

Contact Administrator

We have an online and telephone messaging service for residents to contact the BRA. The Contact Administrator will receive these contact messages via a BRA email account, and forward them on to the relevant BRA committee member for follow up. The administrator should have access to a laptop/PC to manage the messages of which there are two or three a week.

Road Stewards

Our team of Road Stewards are responsible for the delivery of the BRA Newsletter twice a year and collection of the annual BRA subscription.

Unfortunately we do not have Road Stewards for all roads in Bookham which means we do not have volunteers to deliver Newsletters or collect subscriptions, to you and your neighbours.

All we need is a commitment of a few hours in the Spring and Autumn to deliver to around twenty homes.
