

Consultation to change age range of Polesden Lacey Infant Academy

The Proposal

Polesden Lacey Infant Academy, with the support of LEO Academy Trust and Polesden Lacey Playschool, are proposing to change the age range of Polesden Lacey Infant's from 4 - 7 years to 2 - 7 years.

Why are we making these changes?

LEO Academy Trust, Polesden Lacey Infant Academy and Polesden Lacey Playschool recognise and value the importance of strong partnerships with parents in guiding and supporting the beginning of their child's educational journey. We understand the challenges that working families face and acknowledge the importance of a comprehensive and cohesive educational pathway from early years through to primary school for all families.

With this in mind and aligned to the Government announcement to extend the early years funded entitlement to families of all 2-year-olds from April 2024, we propose to extend our age range from 4-7 to 2-7. By doing this we believe we will maximise the educational benefits and wider opportunities available to our pupils and further support the families from the local community.

Details of the proposal

Polesden Lacey Infant Academy and LEO Academy Trust, in agreement with Polesden Lacey Playschool, propose to introduce a nursery provision for both three and four year olds, and two year olds which will mean lowering its age range to be from the age of two years, offering families the option of a continued education for their children from 2-7 years. The children who are currently at Polesden Lacey Playschool will automatically become members of Polesden Lacey Infant Nursery provision, as will those due to start in September. The waiting lists of the currently Playschool will remain in place.

How will this proposal be implemented?

To amend the age range of the academies mentioned above, Polesden Lacey Infant Academy and LEO Academy Trust (the multi-academy trust) must now consult with all stakeholders. Please could you complete the form below as part of the consultation.
